

Americas Highlights

35 deals priced last week for \$7,289.3 M

- In U.S. economic news, fourth-quarter GDP came in at 2.6%, below both the prior reading of 3.2%, and estimates of 2.9%. Additionally, the fourth-quarter GDP deflator came in at 2.4%, matching the estimates and beating the prior reading of 2.1%. Additionally, new home sales in December registered 625,000, lower than the downwardly-revised 689,000 sales in November and short of consensus estimates of 679,000.
- In labor news, initial claims were reported as 233,000, above the prior week's downwardly-revised reading of 216,000, and falling below consensus estimates of 240,000. Additionally, continuing claims for the week were reported as 1,937,000, below the last week's upwardly-revised reading of 1,965,000.

EMEA Highlights

6 deals priced last week for \$1,213.9 M

- The Eurozone consumer confidence index more than doubled in January, to 1.3, over December's 0.5. According to the European Commission, this is the fourth highest reading of the metric on record.
- In the U.K. GDP expanded 0.5% from the prior-quarter, higher than a forecasted 0.4%. This was a welcome increase, given that, for the year, GDP grew only 1.8%, trailing behind 2016 growth of 1.9%. This is the lowest GDP growth in the UK since 2012. The services sector grew 0.6% in the fourth-quarter, the fastest growth seen by services in a full-year.




16 deals priced last week for \$2,187.7 M

- Japan's producer prices rose 0.8% on-year during December, which was unchanged from the prior month and matched economists' expectations. Producer prices were up 0.2% on a monthly basis after adding 0.1% in November.
- •Hong Kong's foreign trade deficit grew by a notable margin in December, rising to HK\$59.9 billion from HK\$45.5 billion in the same month last year. The deficit was substantially larger than what economists predicted it would be, which was HK\$45.9 billion. The shortfall was also a large increase from the HK\$39.7 billion figure reported in November.




