



Americas Highlights

16 deals priced last week for \$2,826.7 M

- In U.S. economic news, the MBA mortgage applications index fell 6.6% for the week ended February 17, lower than the prior week fall of 4.1%.
- In labor news, initial claims for the week ended February 17 were reported as 222,000, below the downwardly-revised prior week's reading of 229,000, and missing consensus estimates of 233,000. Additionally, continuing claims for the week ended February 10 were reported as 1,875,000, below the upwardly-revised prior week's reading of 1,948,000

EMEA Highlights

9 deals priced last week for \$1,425.1 M

- The United Kingdom saw lower-than-expected GDP growth in Q4 of 2017, due in large part to a decreased estimate for production output. GDP increased by just 0.4% sequentially, as opposed to initially reported estimates of 0.5%. Full year 2017 GDP growth was also revised downward to 1.7% from 1.8%.
- The German economy grew 0.6%, sequentially, in the fourth-quarter of 2017. This change matches estimates initially published on February 14th. 2.7% growth in exports contributed to the strong overall performance and reflects increasing foreign demand.

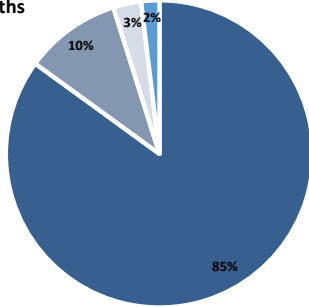
7 deals priced last week for \$1,768.5 M

- Japan's producer prices in January increased 0.7%, slightly missing analysts' expectations of a 0.8% gain. Additionally, month-over-month, producer prices fell 0.6% following the 0.2% jump seen in December. Meanwhile, prices were also down for leasing, transportation and financial services.
- Singapore's consumer prices remained flat in the month of January, lower than analysts' expectations and December's increase of 0.4%. Meanwhile, core inflation jumped to 1.4% in January from the 1.3% rise seen in the prior-month. From a month-on-month standpoint, consumer prices fell 0.2% following the 0.1% drop seen in December.

Top Market Share By Exchange Country:

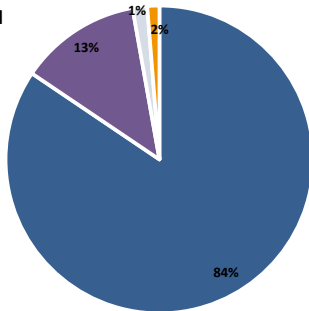

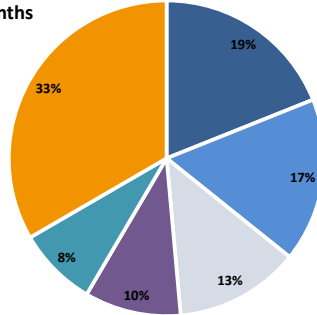

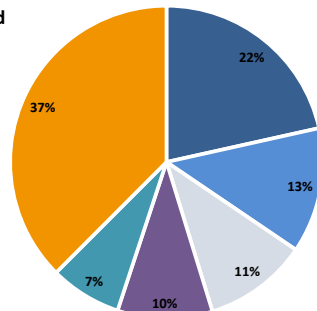

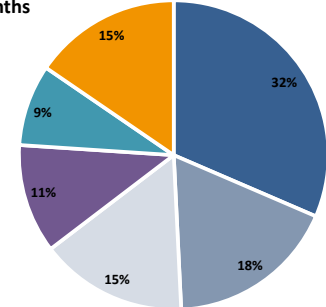

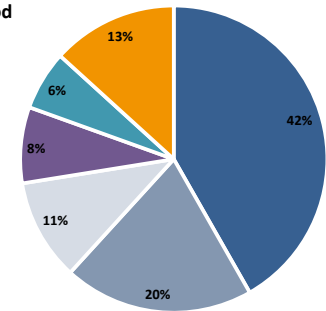
