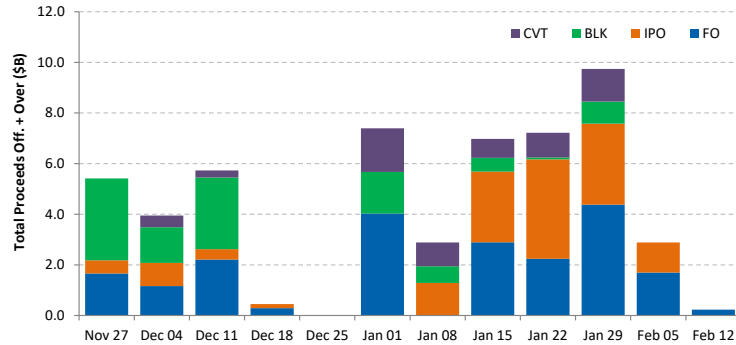

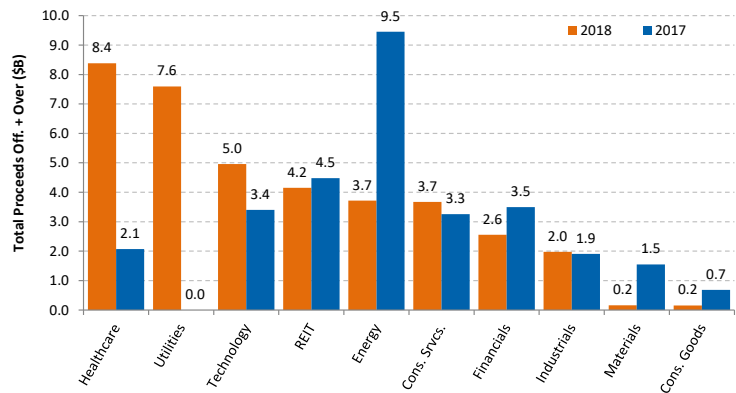

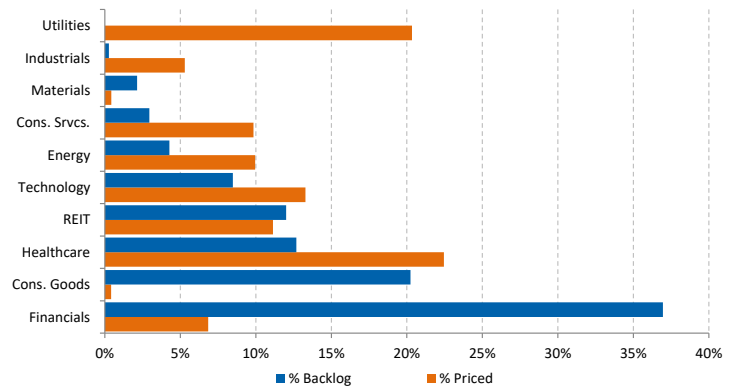
### Trailing 12-Week US Proceeds by Deal Type

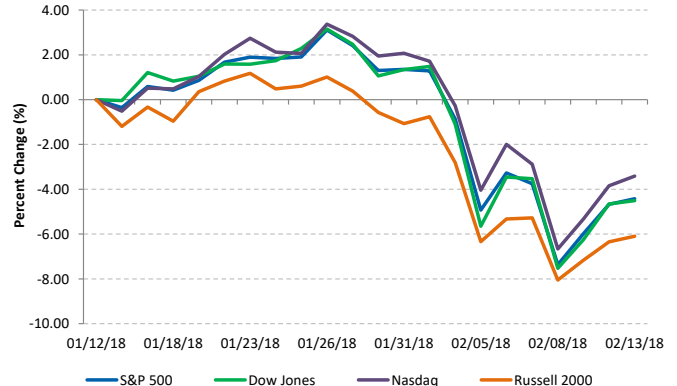
